Important Note for MBBS (Code 103): Candidates who have studied 10+2 (11<sup>th</sup> and 12<sup>th</sup>) from a recognized School/College in Delhi and passed the qualifying examination from any School/College located in Delhi only shall be eligible for the seats of Delhi Category / Quota. Such candidates need to upload their both 11<sup>th</sup> and 12<sup>th</sup> class marksheet in a single pdf while uploading documents.
