The Hostel Accommodation will be provided initially for fresh batch 2021-22 in triple sharing rooms only at the time of admission / joining. Any option to other type of accommodation will be considered only after a period of 6 months.

Fee structure for M.B.B.S. under NRI Category

For NRI quota admission, fee for the entire duration of the course is 375,000 USD payable in 5 equal annual installments of 75,000 USD each year, on or before the date prescribed by the University.

IV. Eligibility for admission to M.B.B.S. degree course:

(i) The candidates should have completed the age of 17 years on or before 31st December 2021. The candidates completing the age of 17 years on 1st January 2022 or later on will not be eligible for admission, i.e., the candidate must be born on or before 31.12.2004.

(ii) Candidates should have qualified in the National Eligibility-cum-Entrance Test NEET-UG 2021 conducted by the National Testing Agency, New Delhi.

(iii) Candidates should have obtained the minimum percentage of marks in the qualifying examination as per Medical Council of India norms.

(a) Candidates must have passed in the subjects of Physics, Chemistry, Biology / Biotechnology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology / Biotechnology in the qualifying examinations.

(b) In respect of candidates belonging to scheduled caste, scheduled tribes or other backward classes the minimum marks obtained in Physics, Chemistry and Biology / Biotechnology taken together in qualifying examination shall be 40%.

(c) In respect of candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 the minimum marks in qualifying examination in Physics, Chemistry and Biology or (Botany and Zoology) / Biotechnology taken together shall be 45%.

(iv) All admissions to MBBS degree course within the respective categories shall be based solely on the marks obtained in the National Eligibility cum Entrance Test (NEET).

For all other eligibility conditions, Medical Council of India / National Medical Commission, New Delhi website may be referred.

The candidates who do not qualify the NEET-UG-2021 Examination conducted by NTA are not eligible.

V. Counselling

As per the Gazette Notification added in the Medical Council of India Regulations, there shall be a common counseling for all seats of NEET UG 2021 at National level to be conducted by the Medical Counseling Committee, New Delhi.

Candidates who intend to apply for admission to M.B.B.S. degree courses for the academic year 2021-22, in Chettinad Hospital and Research Institute are advised to register themselves through online web portal of Medical Counseling Committee for participating in common counselling and they are advised to periodically check the MCC website for updates viz., Frequently Asked Questions (FAQ), Schedule/re-schedule of counselling dates and its process etc.

VI. Procedure of admission and details about payment of fees:

On obtaining the online provisional allotment letter from the Medical Counseling Committee, New Delhi, the allotted student shall report to the **University office at Chettinad Academy of Research and Education**, Chettinad Health City campus, Rajiv Gandhi Salai, Kelambakkam - 603 103, Chengalpattu District, Tamil Nadu and submit the allotment letter within the due date as indicated in the allotment letter.

Candidates provisionally allotted for admission and will have to submit all required original certificates with the Institution and pay the tuition fee and other applicable fee etc., for the academic year 2021-22. Otherwise he/she shall forfeit his/her offer of admission to the course in the Institution without any notice and will have no right to claim the seat, in future.

Candidates are requested to submit the community certificate (OBC-NCL/SC/ST) as per format prescribed in the NTA information bulletin. Therefore, candidates are advised to keep with them sufficient number of photocopies of their certificates.

No extension of time for payment of fees or for submission of original certificates for verification will be entertained under any circumstance.

Candidates provisionally selected for admission will have to undergo a medical examination at Chettinad Hospital & Research Institute and only those who are found medically fit will be allowed to join the course.

VIII. Rules for Refund:

The amount of fee to be deducted in case candidate resigns after counseling period/cutoff date:

Where any student applies for discontinuance, or without any application discontinues on his/her own, from the course to which he/she has been admitted to, for any reason, either on or after the cut-off date prescribed by the statutory and/or University authorities for admission to the first year of the course or where the seat is rendered vacant without having any chance of being filled up with any other candidate such students will have to remit the tuition fee and other applicable fees for the 'entire/remaining course period'.

IX. General Information:

- The selection and admission to MBBS seats in this University is subject to fulfilling the eligibility, medical fitness and such criteria as may be prescribed by the Medical Counseling Committee, New Delhi, Medical Council of India / National Medical Commission and this University. If it is found at a later stage, that the candidates have submitted false information / forged certificates, his/her admission will be cancelled without any notice, fee paid will be forfeited and the same shall be final and binding.
- Admitted students are bound by the Rules and Regulations of this University framed from time to time in the matter of syllabus, examinations, fee structure, discipline and policy for refund of fee etc.
- Candidates with provisional allotment letter are advised to submit all the necessary original documents, pay the tuition and join as early as possible and not to wait for last day of joining, considering the time required to complete admission formalities.
- Candidates who have deposited their original documents with any other Institute/College/University and come for admission with a certificate stating that "their original certificates are deposited with the Institute/College/University" will not be allowed to take admission as directed by MCC, New Delhi. Without original documents and payment of tuition fee candidate will be considered as "Not reported".
- Candidates himself / herself must be present at the time of reporting. No proxy will be allowed in any circumstances.

- If a candidate fails to report on the date and time specified by MCC of DGHS in the allotment order along with the original Certificates/Documents and/or fails to pay the tuition fee by Demand Draft/Electronic Fund Transfer through RTGS with UTR No. (For NRI Students Wire Transfer) on the day of admission, he/she will not be permitted to proceed with the admission process.
- Where any student applies for discontinuance, or without any application discontinues on his/her own, from the course to which he/she has been admitted to, for any reason, and the seat is rendered vacant without having any chance of being filled up with any other candidate such student, will have to remit the tuition fee and other applicable fees for the 'entire/remaining course period'.
- All disputes arising in the interpretation and implementation of the provisions in this information bulletin will be referred to the Vice Chancellor, Chettinad Academy of Research and Education and the decision of the Vice Chancellor shall be final and binding.
- The University reserves the right to change any of the conditions enumerated periodically or for the purpose of complying with any of the regulations of the statutory councils
- In respect of matters relating to or arising out of this information bulletin, the jurisdiction shall be at Chennai alone.
- It is a general advisory to all students admitted in MBBS course at Chettinad Hospital and Research institute that they do not avail any long period of leave during the course of study and try to complete the course within the stipulated period as prescribed by NMC/MCI. A learner shall not be entitled to graduate later than ten (10) years of her / his joining the first MBBS course.

Date of Birth and Name Registered as per School Records:

- The Name and Date of Birth of the candidate will be registered in the records of the University as given in the HSC Mark Statement / Transfer Certificate. No request will be considered later in regard to a change of Date of Birth or correction in the Name of the candidate. The parents and candidates are

requested to verify and confirm these entries in the HSC Mark Statement / Transfer Certificate at the time of admission into the course without fail.

X. Ragging in any form is prohibited in the University Campus:

The University follows a Zero Tolerance Policy towards Ragging. Ragging in any form is a crime and a punishable offence. As per the directions of the Hon'ble Supreme Court of India, University Grants Commission has framed "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and the Medical Council of India has framed "(Prevention and Prohibition of Ragging in Medical Colleges/Institutions) Regulations, 2009" and notified in the Govt. of India Gazette in order to prohibit, prevent and eliminate the scourge of ragging. These regulations are mandatory and provides for punishment of those who abet and indulge in ragging, directly or indirectly.

- vi. Original 12th std. Mark sheet of HSC/CBSE/ISCE
- vii. NRI candidates who have passed the 12th Grade Diploma from the U.S. should have passed the subjects (i.e. Physics, Chemistry, Biology (Botany and Zoology) and English) during their 11th& 12th year of study.
- viii. Equivalent Certificate from Association of Indian Universities for Foreign qualification
- ix. Community Certificate (SC/ST/OBC-NCL Candidates must submit the certificate issued by the competent authority as per the format prescribed by NTA information bulletin).
- x. Original Transfer Certificate from the Institution last studied
- xi. Original Conduct Certificate from the Institution last studied
- xii. Original Migration Certificate (if applicable)
- xiii. Copy of Certificate of Extracurricular activities (if any)

- xiv. Demand Draft for the prescribed fees in favour of **Chettinad Hospital & Research Institute payable at Chennai** or through RTGS / internet banking.
- xv. Recent passport size photographs - 6 copies (same as in NEET- UG 2021 admit card).

Capture of thumb prints – The left & right thumb prints of reporting candidates will be captured electronically.

Capturing of digital image – Digital image of the reporting candidates will be captured and taken on record.

The candidates are informed that during the time of original certificate verification (H.S.C. Marks, T.C., Community certificate etc.,) in the counselling venue or at the time of admission if it is found that a candidate has been involved in impersonation/suppression or misrepresentation of facts and produced falsified/bogus certificates by the candidates, his / her name from the admission list will be cancelled at any stage.

XII. For NRI / OCI / PIO Candidates:

The definition of NRI for admission to Deemed Universities shall be as per Hon'ble Supreme Court order dated 22.08.2017 in WP No.689/2017.

Admission in MBBS degree course under NRI quota for 2021-22 shall be based on the NEET UG 2021 qualification and shall come through MCC counseling.

Please note that the tuition fee for NRI candidates should be remitted in US Dollar only.

Candidates who fall under the category NRI as per the direction / orders of the Hon'ble Supreme Court of India in the case (W.P. (C) No.689/2017- Consortium of Deemed Universities in Karnataka (CODEUNIK) &Anr. Vs. Union of India &Ors.) dated 22.08.2017 are eligible for NRI category.

 - V. First degree – Paternal and Maternal Cousins Such person should be NRI
3. Affidavit from the sponsorer that he / she will sponsor the entire course fee of the candidate duly notarized.
4. Embassy Certificate of the Sponsorer. (Certificate from the Consulate)

OCI card holders, even if they opt to come under General Category, have to submit their Passport and OCI card copies, along with originals, for purpose of record.
