Hidayatullah National Law University (HNLU), named after one of the greatest legal luminaries of the country, Hon'ble Shri Justice Mohammad Hidayatullah, was established in 2003 by the Government of Chhattisgarh Hidayatullah National University of Law, Chhattisgarh, Act, (No. 10 of 2003). Situated in the lush green surroundings of the well-planned city of Nava Raipur, HNLU is one of the most sought-after destinations of legal education in the country of students from all over India. The University, named after the illustrious jurist-statesman of India, Late Hon'ble Justice Mr. M. Hidayatullah, has state-of-the-art facilities of academic and living spaces for students, faculty, and staff.

Following its motto of 'Dharma Sansthanartham' which means 'for the sake of establishing the primacy of the laws of eternal values', HNLU strives towards imparting advanced legal education by engaging in teaching and research and seeks to develop among students a sense of responsibility to serve the society in the field of law by taking to advocacy and reforms in law and justice administration system. Hidayatullah National Law University has completed the journey of more than one and half a decade. HNLU is the sixth in the series of National Law Schools across India. HNLU has been included in the list of the Universities maintained by the University Grants Commission under Section 2(f) of the UGC Act, 1956 and has been declared fit to receive Central assistance in terms of the rules framed under Section 12 (B) of the UGC Act, 1956. The university is recognized by the Bar Council of India under section 7 of the Advocates Act 1961. HNLU CAMPUS AT A GLANCE

ACADEMIC BLOCK – THE LEARNING PARLIAMENT



The Academic-Administrative block of the University has been built taking inspiration from the architectural design of the Parliament of India. It is fully equipped with a wireless internet connection, modern teaching aids including smart classrooms, and necessary equipment making learning an effective experience at HNLU.

AMPHITHEATRE - AN ATHENIAN EXPERIENCE



The Academic block also houses a unique *Amphitheatre* right in the centre of this block taking structural design inspiration from the Amphitheatre of Athens and has a seating capacity of 1000 students which is used for cultural festivals and other outdoor gatherings of students, staff and faculty.

CONGREGATION OF MINDS

A State-of-the-Art aesthetically designed Conference Hall with a seating capacity of 400 students is the epicentre of many curricular and extra-curricular events which the University hosts throughout the year.

A ‘CLASS’ EXPERIENCE

The University boasts of 28 fully air-conditioned smart classrooms equipped with smart boards and LCD Projectors in the circular block and new block. The University also has a dedicated ‘**Language Lab**’ specifically designed and equipped with modern software and gadgets for supplementing the classroom teaching of language papers thereby improving the overall communication and presentation skills of the students.

VICE-CHANCELLOR’S MEANS-CUM-MERIT SCHOLARSHIP SCHME (VC-M²S²)

The Hidayatullah National Law University, Raipur has launched the Vice Chancellor’s Means cum Merit Scholarship Scheme. The Scheme aims to provide financial assistance to economically disadvantaged but meritorious students of UG & PG courses of the University. The scheme will provide scholarship to the tune of 50 % of the annual fees to a total of 24 students of II to V Year of B.A., LL.B. (Hons) and 6 students of LL.M. every year for the second semester.

BANKING AND ANY TIME CASH

The University has an in-house bank branch of IDBI and two ATM centres of IDBI and SBI in the campus.

UNIVERSITY’S HEALTH POLICY

Medical Centre

The University has tied up with a multi-speciality hospital to provide on-campus consultation of Male and Female doctors in the morning and evening and whole time nursing care. The Clinic located in the Utility Centre has beds and essential pharma stocks. The University has two ambulances with dedicated drivers for servicing any outdoor consultations of hospitals.

Insurance Cover for University Students

The University will also unveil an insurance cover to students from the forthcoming semester managed from the medical component of the fee paid by them.

Counselling Facility

The University has for the last two years an online counselling facility with a professional counselling agency called 'My Dost'. Apart from that in the coming academic session, the University will add a visiting Counsellor for the students.

LIBRARY

HNLU library is considered as a frontline library among all the libraries of national law schools owing to its diverse and rich collection of reading materials where one can realize and enrich his/her domain of knowledge in all the best possible ways. As far as the infrastructure is concerned, our library is a huge three-story with a seating capacity of over 600 students and is Wi-Fi enabled building fully air-conditioned and comfortable enough to have an awesome experience of reading and assimilating knowledge. The library has well stacked rich collection of textbooks, journals, reference books, and periodicals. Additionally, with vast and vivid sources of reading, Library provides various online learning platforms and interfaces like Taxman, Legit quest, Thomson Reuters, SCC Online, Manupatra, Hein Online, Westlaw, EPW, Jstor, Kluwer Arbitration, Cambridge Core Journal, etc. All stakeholders through RemoteXs have accessed these services remotely and various on boarding sessions also took place for first-year students.



It also houses environment-friendly spacious lounges which are just below the open-to-sky area protected from rain and direct sunlight by transparent polycarbonate roof. All-day long, this area of the library is lighted by natural light. The lush green Amphitheatre visible through transparent glasses from the library creates an eco-friendly and aesthetic ambiance for the library users to concentrate on and enjoy their reading.

MOOT COURT HALLS

Moot Court Cluster at HNLU is the laboratory to test the Advocacy skills of the students of HNLU. There are six fully furnished Moot Court Halls available on Campus and all the Court Room Exercises are conducted there.

HALLS OF RESIDENCE and DINING HALL



The University also has spacious Halls of Residences spread across the campus with boys and girls wings. The Boys Hostel cluster called '*KAILASH*' is named after the beautiful caves of Chhattisgarh and the Girls hostel cluster named '*VITASTA*' named after the

beautiful River Jhelum. Both the Boys and Girls hostel have a total of 629 rooms each spread across 4 separate sub-hostel wings.

The hostel rooms are fully furnished with a Cot, Table, Chair, and Almirah and every room also have a separately attached balcony. Every wing of the hostel has its own dedicated State-of-the-art Kitchen and Air-Conditioned Dining Hall. Each hostel wing has a well-built and advanced gymnasium complex and a common room with pre-installed cable TV for recreational activities. The hostels do have a night canteen catering late nights.

Each hostel wing and dining area is equipped with RO water filters and water coolers. The washrooms are equipped with Solar powered Hot Water facilities and the University also has plans to establish a centralized RO Plant in the coming academic year.

SPORTS FACILITIES

Both boys and girls have a state-of-the-art Gymnasium in the central hostels with indoor badminton courts and table tennis facilities. Outdoor sports facilities inside the campus include a Football ground with a proposed synthetic running track around it, a Cricket ground, a Lawn tennis court, two Basketball courts, and one Volleyball court respectively.

SAL – THE UTILITY CENTRE

For catering to the daily needs of the students, the University houses Multi-Need Complex called SAL – the Utility Centre. This centre comprises of 8 shops which sell, dairy products, snacks, and beverages, fruits, stationery shop with printing, scanning and photocopying facilities, Unisex Salon for residents and a mini restaurant by the lakeside.



MEDICAL FACILITIES

The following health infrastructure has been put in place for the students:

Medical Centre

HNLU also hosts a multi-functional medical centre which serves as an out-Patient facility with male and female doctors visiting campus with a pre-fixed schedule. The University has tied up with a multi-speciality hospital to provide on-campus consultation to the students on daily basis.

Last semester, the University had tied with Ramakrishna Care Hospital and this semester the University has contracted with Balco Medical Centre in Naya Raipur for regular medical consultations.

Counselling for Mental Health

The University has also engaged this year the services of a professional lady psychologist for on campus and off campus consultation. The University also has an MoU with Your DOST, a premier online counselling service provider.

Insurance Cover for University Students

HNLU is the first amongst Nation Law Universities to implement an insurance scheme for its undergraduate and postgraduate students as part of its comprehensive Campus Health Initiative (CHI). HNLU has selected National Insurance Company which will provide a cover of Rs. 1,00,000/- for individual students. This scheme is accommodated within the component of medical fee of the fee structure and not charged additionally to the students.

On-Campus Services

In view of the recent reported cases of viral fever, the University with the assistance of the local public health authorities arranged for testing of students for Covid-19 and Swine Flu.

HNLU is also one of the very few Universities to have a sanitary napkin incinerator in the hostels.

Ambulances

The University has two ambulances with dedicated drivers for servicing any outdoor consultations of hospitals.

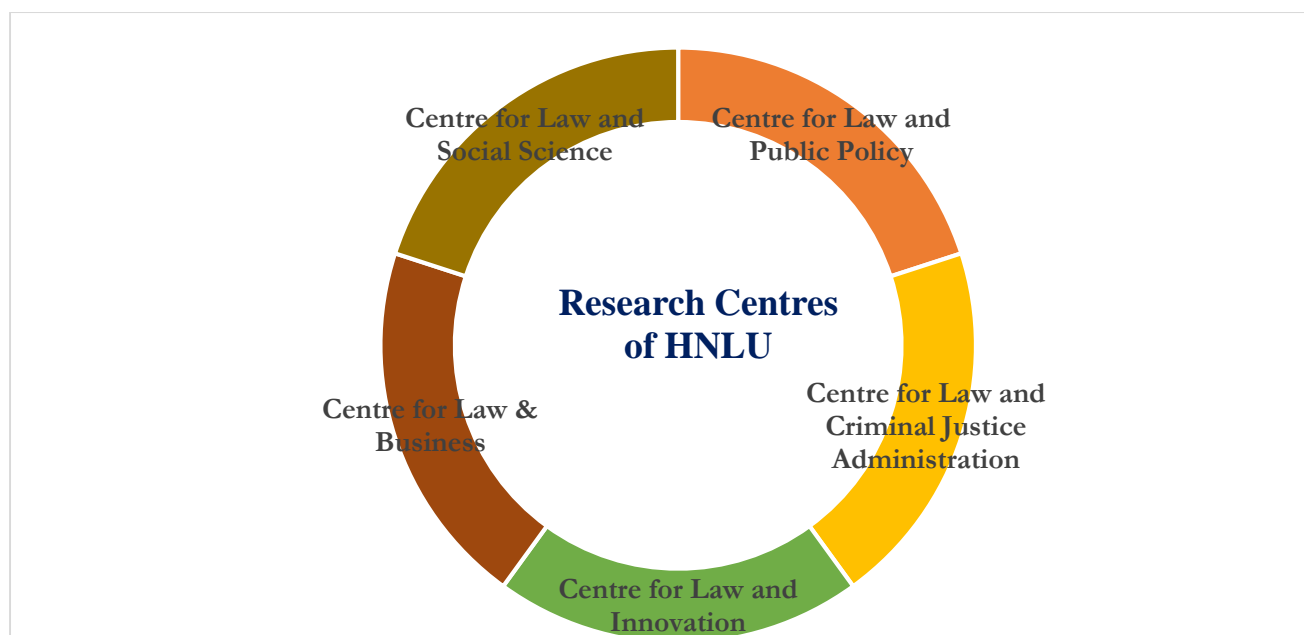
TRANSPORTATION FACILITIES

The University operates three city shuttle buses (50 seaters on all evenings from campus to city center for shopping, dining, and other entertainment needs. The nearest bus station is located at a distance of 1 km wherein a City corporation bus operates every 15 – 20 minutes. The Swami Vivekananda Airport is 15 minutes drive from the campus and the Raipur railway station is 35 km. from the campus.

BEYOND CLASSROOMS

RESEARCH CENTRES

The University is revamping the research centers headed by faculty and involving young student scholars to participate in contemporary advocacy. HNLU Research Clusters is in the final stages of planning and will cover

LEGAL AND SOCIAL SERVICES

Legal Aid plays an important role in the legal profession and HNLU through its Legal and Social Services Committee strives to ensure justice by furthering the right to be heard and enlightening the students about the practicality of the functions of the complex government machinery. The Legal and Social Services Committee, which is established as a part of the Bar Council of India's mandate with every institution imparting legal education, is formed to spread awareness on precipitating legal issues faced by the communities at large and also to provide avenues for underprivileged members of the society to resolve their legal issues on a pro-bono basis. The Legal and Social Service Committee which was established with this fundamental objective in mind played a crucial role during the pandemic and moved beyond its statutory mandate.

MOOTING CULTURE

With the financial assistance received from the Government of Chhattisgarh, the university spends Rs. One crore every year for the participation of students in moot court competitions, seminars, conferences, and workshops at the national and international levels. Our students, on multiple occasions, have brought laurels to the University by showing steely talent in various prestigious moot court competitions. This year, our students have won the coveted West and South Asian Rounds of the 19th John H. Hidayatullah Memorial National Moot Court Competition

The university has been regularly organizing since 2007 the Justice Hidayatullah Memorial National Moot Court Competition (HNMCC) on annual basis to promote the culture of mooting among the students. HNMCC was started as a part of the centenary celebrations of the eminent jurist, author, and linguist, Justice Mohammad Hidayatullah. Over the course of a decade, it has established a reputation for being one of India's premier moot court competitions.

CULTURAL SPACE

The student initiative of **Colossus** is a three-day festival of culture and sports that attracts students from across the country. Ex-Arca

‘*Ex Arca*’, which literally means an ‘out of the box’ idea is a blended platform of Online and Offline dissemination of the interface of Arts & Humanities, Social Sciences, Science & Technology, and management with law. The core purpose of ‘*Ex Arca*’ is to support and supplement the understanding of law students going beyond the classroom discourses and develop an understanding of industry requirements thereby bridging the knowledge gap between the theory and practice of law.

Alma Matters

The ‘**Alma Matters...**’ platform designed at HNLU aims to invite, honour and get inspired from the Alumni of their turbulence and triumphs, ambivalence and achievements for an inter-generational motivation.

‘HNLU PRESS’ – a publication division of Hidayatullah National Law University to publish and disseminate print/electronic and multimedia content. HNLU PRESS aims to scale up the existing publication efforts apart from launching new initiatives in the field of Law and other disciplines interfacing Law. This platform aims not only to publish legal research articles from established contributors but to encourage young talents to contribute.
