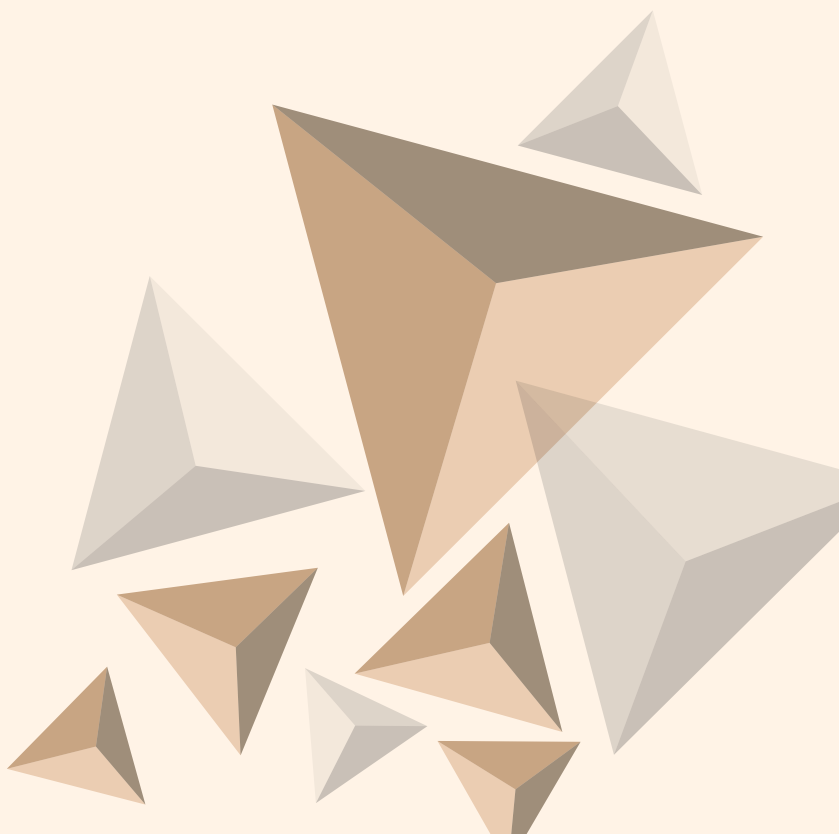

SLRTCL offers two courses in law:

(1) Three Years Law

(2) Five Years Law degree Courses

Each of these Courses is independent of the other and is in accordance with the rules laid down by the University of Mumbai and the Bar Council of India. The admission procedure is being notified by displaying it on the notice board of the college and putting them up on the official website of the college.

L L B. in 3 years

1) The 3 Years Law Courses LLB. is a six semester fulltime course. On completion of the three year course, i.e after the 6th semester, the LLB. degree is awarded. Students who desire to study the law, but do not wish to practice as advocates are eligible for the LL.B. (General) Degree, at the end of 2nd Year i.e. after the 4th semester. They are, however, not eligible to practice as advocates.

B L S., L L B. in 5 years

2) The 5 years Law Course, leading to B L S., LLB. is a ten semester full time courses. The first and second year of the five course, i.e 1st to 4th semester is a "Pre-Law courses". The Students of the five year degree programs are awarded the B.L.S. (Bachelor of Legal Science) degree at the end of the third year (i.e. Sixth Semester) and on completion of five years, (10th semester the LLB. degree is conferred.)



Eligibility Criteria

Admission to the 5 years Law Courses

A candidate passing the H.S.C. (10+2) examination conducted by the Maharashtra state board of Secondary and Higher Secondary Education, with minimum 45% marks or any other examination recognized as equivalent there to by the university of Mumbai with the minimum prescribed marks is eligible for admission to the first Year of pre law course.

The above percentage of marks shall be relaxed by 5 % for the candidates belonging to reserved categories.

Admission to 3 years Law Courses

A candidate passing the Bachelor's degree Examination of the Mumbai University, in any faculty with minimum 45 % marks or corresponding degree examination of any other University recognized as equivalent there to by the Mumbai University with the minimum prescribed marks is eligible for admission to the first year LLB. The above percentage of marks shall be relaxed by 5% for candidates belonging to the reserved Categories. Admission is given strictly on merit.

A student who has successfully completed three years course is entitled to LL.B. degree and is eligible to practice as an advocate, as per the Rules of the Bar Council of India, A student who desires to take education in law but does not wish to practice as an advocate is eligible for the LL.B. (General) Degree at the end of two years.

Procedure for seeking admission to the five years & three years courses

Admission process for the first year of the Five Years Law Course will commence immediately after the declaration of H.S.C. results and in the case of Three Year Law Course, after the declaration of graduation results.

Total Seats available for 1st year of B.L.S., LLB. (Five Year Law Course) - 1 Divisions unaided total 60 seat

Total seat available for 1st year of LLB. (Three years Law Course) - 1 Division unaided total 60 seat.

Please note:-

• The matter of reservation for the candidates falling within the categories of S.C., S.T., O.V.C. etc. is in accordance with the relevant Government Resolutions issued by the state of Maharashtra. • The Prospectus and the Registration Forms will be available at the College Office, The Registration Form, duly filled in, should be submitted to the college within the prescribed time. The merit lists in all the categories viz. reserved, general etc. are prepared on the basis of the marks secured in the qualifying examination. • Therefore the candidate from out of Mumbai University desirous of applying for admission to SLRTCL are informed that is imperative to submit along with their application forms the official transcripts to enable this college to determine the exact marks obtained by them. This will be all the more necessary if the mode of evaluation, in the said university is other than marks secured like gradation etc. • Their applications will not be considered in the event of failure to make compliance with this requirement.

Admission Requirement

Admission must be taken by the students in person, by submitting the following documents:-

- Original Statement of marks with certified copy
- Original Caste Certificate by student intending to avail benefits of the under mentioned categories:-
 - a) Scheduled Castes
 - b) Scheduled Tribes including those outside specific areas, (caste validity)
 - c) De-notified Tribes.
 - d) Nomadic Tribes (with non creamy layer certificate)
 - e) S.B.C.
 - f) Other Backward Classes. (with non creamy layer certificate)
- Passing certificate and certified copy of document indicating the date of birth, for example, school leaving certificate.
- Three recent passport size photographs.
- In case of students migration from another University, provisional eligibility certificate from the Mumbai University. Application for eligibility is to be made to the Registrar, Mumbai University in the prescribed form along with prescribed fees through college office.
- In case of a student from a college affiliate to the Mumbai University, Transference Certificate (T.C) from that college. The application for Such TC's should be sent through this college in the prescribed form.
- Foreign student seeking admission should produce their passport and student visa at the time of admission. Foreign student holding tourist visas or entry visas will not be considered.
- At the times of admission every student must undertake to attend at least 75% of the total number of lectures held in each semester.

Examination

Scheme of Examination for Undergraduate 3 Years LL.B. and 5 Years B.L.S., LL.B. programme shall be as mentioned below:

The performance of the learners shall be evaluated into two components. The learner's performance shall be assessed by Internal Assessment with 40% marks in the first component by conducting the Semester End Examinations with 60% marks in the second component. The allocation of marks for the Internal Assessment and Semester End Examinations are as shown below:-

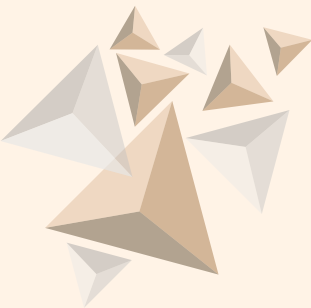
For the Semesters I to IV of the 5 years B.L.S.,LL.B programme, the assessment of 'Part A' i.e. Internal Assessment and Part B i.e. Semester End Examination shall be processed by the Colleges / Institutions of their learners on behalf of the University and declare their results as per the procedure laid down by the University. The Colleges / Institutions shall accordingly issue the grade cards to them after conversion of marks into grade as per the procedure mentioned in this manual. The format of the grade card is given hereinbelow to maintain the uniformity across the all colleges for the examinations conducted by the colleges on behalf of the University.

For the Semesters I to IV of the 3 years LL.B. programme and Semesters V to VIII of the 5 years B.L.S.,LL.B programmes, the assessment of 'Part A' i.e. Internal Assessment and Part B i.e. Semester End Examination shall be processed by the Colleges / Institutions of their learners on behalf of the University and declare their results as per the procedure laid down by the University. The Colleges / Institutions shall accordingly issue the grade cards to them after conversion of marks into grade as per the procedure mentioned in this manual. The format of the grade card is given hereinbelow to maintain the uniformity across the all colleges for the examinations conducted by the colleges on behalf of the University.

For the Semesters V & VI of the 3 years LL.B. programme and Semesters IX and X of the 5 years B.L.S.,LL.B programmes, the assessment of 'Part A' i.e. Internal Assessment shall be processed by the Colleges / Institutions on behalf of the University of the learners admitted for the programme while the University shall conduct the assessment of 'Part B' i.e. Semester End Examination. The Internal Assessment marks of learners appearing for these Semesters shall be submitted to the University by the respective colleges/Institutions before commencement of respective Semester End Examinations. The Semester End Examinations for Semesters V & VI of the 3 years LL.B. programme and Semesters IX and X of the 5 years B.L.S.,LL.B programmes shall be conducted by the University and the results shall be declared after processing the internal assessment and the marks awarded to the learners. The grade cards shall be issued by the University after converting the marks into grades.

Passing Standard (for Undergraduate Law Programmes)

The learners to pass a course shall have to obtain a minimum of 40% marks in aggregate of Internal Assessment & Semester End Examination taken together; however the learners shall have to obtain minimum of 30% marks in the Internal Assessment (i.e. 12 out of 40) and 30% marks in Semester End Examination (i.e. 18 Out of 60) separately, to pass the course and minimum of Grade E in each course, to pass a particular semester. A learner will be said to have passed the course if the learner passes the Internal Assessment & Semester End Examination.



Eligibility for Admission to the Semesters

5 Years L. L. B. Course

A Candidate, in order to be eligible for admission to the Third Semester, must have either passed in the first and Second semester or should have received an examination in at least four papers of the first and Second Semesters.

Similarly, for a candidate to be eligible for admission for the fifth Semester, must have passed the first & Second Semester, & must have either passed in Third & fourth Semester or must have got exemption in at least 4 papers of the Third & forth Semester Examinations.

A Candidate, for being eligible for admission for the sixth semester, must have successfully kept the terms for the sixth semester, must have successfully kept the term for the fifth Semester, irrespective of the result of the fifth Semester examination.

A candidate, for being eligible for admission to the Seventh Semester must have passed in all papers of first to fourth semester, and must have either passed in all Papers of First to fourth Semester, and must have either passed in the examination of the fifth and sixth Semester, or must have got exemption in at least six papers (including Practical Training papers) of the Fifth and Sixth Semester.

A Candidate, for being eligible for admission to the Eight Semester must have successfully kept the terms for the Seventh semester examination.

A candidate, for being eligible for admission to the Ninth Semester must have passed in all Papers of First to Sixth Semester, and must have either passed in the examination in the Seven and Eight Semester, or must have got exemption in at least six papers (excluding Practical Training Paper) of the Seventh and eight Semester.

A candidate, for being eligible for admission to the Tenth Semester must have successfully kept the terms for the Ninth Semester, irrespective of the result of the Ninth Semester examination.

3 Years L. L.B. Course

Standard of passing and rules of exemption for the First to Six Semester of the Three Years Law course shall be same as that of Fifth to Tenth Semester of Five Years Law Courses.

Library Facility

The College library has a separated building with spacious stock room, reading halls for staff, boys and girls. The library has a huge collection of books & journals on a variety of subjects.

Rules:

1. While entering the library, students should carry their Identity Cards as well as Library Cards.
2. Students will ensure that they do not disturb other students in the library.
3. Books are issued for home reading for a period of one week only against a demand slip (Duly filled and signed) on days notified for this purpose. Reference Books and prescribed Text Books kept in the reading hall, Directionaries, Encyclopedias, Atlases and other books classified as reference books must be used in the library only during working hours.
4. A Student falling to return books issued for home reading on or before the due date will be liable to pay a fine of Rs.5/- per day till such as the book is returned.

Court Visits / Attendance in Courts

Students under the supervision of a professor in-charge shall visit at least three of the following places during such working day and timing as may be decided by the institution. The object of this course is to enable the students to understand the actual working in some of the departments and the documents maintained by them with a view to familiarized them.

The visits will be to any of the following places :

Office of the Registrars,

Clerk of Court,

Nazirs, Record keepers etc. in courts

Police Station

Office of the Sub- Registrar under the Indian Registration Act

Prison / Jail / Sub-jail.

Chemical Analyzer's Laboratory

Attendance in Courts

Each Students shall be required to attend at least two cases or proceedings or interim petitions of courts, as far as possible from start to finish, arising out of the following:

1. Civil Suits
2. Criminal Cases
3. Session Cases
4. Small causes court proceedings or
5. Proceedings before a Co-operative or and other court as may be decided by the Professor-incharge
6. Field visit to local areas and villages for free Legal Aid Activities, Students shall be required to make their own notes and observation

about the proceedings so visited and attended by them including the facts of the proceedings, legal issues involved and record them in the journal maintain by them. The journal so maintained for this purpose shall be assessed for the purpose of allotting marks under practical training paper.

Attendance at a Lawyer's Chamber

Students under practical training paper shall attend the offices of advocates on such days and during such timings as the concerned Advocates may suggest. The object of this course is to enable a studnet to make himself conversant with the working in an Advocates office as to how he takes instructions form clients and so on. The observation made by the student shall be recovered in the journal under practical training paper and the same shall be assessed for allotment of marks.

Student Travel Concessions

(Long Railway Journal Concession)

Students are entitled to get long journey Concession under all following circumstances :

- a) Form their School, College Or Institution to their homes or vice-versa,
 - b) From training center to home and vice-versa,
 - c) From one training centre to another training centre,
 - d) Concession shall be granted for second class only, expect in case of blind, orthopedic Handicap, T.B. And cancer patient, non infectious leprosy patients.
 - e) Student concessions shall be admissible to only such students who are not under full time employment.
 - f) Only students (including research scholars) up to the age of 25 Years are eligible for concessions.
- In case of Scheduled Castes and Scheduled Tribes, the upper age limit shall be relaxed of 27 Years.

Note: The Term "Home" connotes -

- i) Native Place of the students ; or
- ii) The place where the parents or if no parents is alive, the guardian of the student normally resides.

It is further clarified that when parents are alive, the question of availing of the concession for visiting the guardian cannot arise. The guardian can be visited only if the student has no parents who are alive. Rail concessions for visiting homes are admissible for visiting native place during holidays, vacations, long or short sickness etc.

Local Railway journey Concessions :

The students are entitled to get local journey railway concession between the nearest station of student's residence and the station nearest to the college.

General Rules Regarding Discipline

1. Students shall abide by any general or special rules made by the college authorities in regard to the conduct of the students both in and outside the College, and outside the College, and the decision of the college Authorised shall be final, Parents and Guardians are also presumed to have agreed to these rules when their wards join the College.
2. Students should in their own interest read the College notices, including notices containing rules placed on the Notice Boards from time to times,. It Shall be the duty of each student to scan all the notice boards daily.
3. Students are required to dress decently. Dress code prescribe by College is mandatory.
4. **Use of cell phones it strictly prohibited. Students found using cell phones in class are liable to be fined.**

The Following shall be deemed as acts of indiscipline:

1. Resorting to ragging; A Student involved in any such act is liable to be expelled from the college and in addition may undergo imprisonment and fine.
2. Smoking, Consumption of alcoholic drinks, intoxicants and narcotic drugs.
3. An act which cause destruction or defacing of the property of the college or organizing raids and breaking into the premises of College.
4. An Act which interferes with the personal liberty of another person or subject another to indignity, or involves physical violence or use of abusive language.
5. An act in breach of an undertaking given under the rules of discipline.
6. Refusal to establish or renewal identity in the premises of the college.
7. An act which causes interference of outside person or bodies or Agencies in the functioning of the college.
8. Dissemination & assertion of any false statement or tempering of certificates and records, whether with a view to seeking admission in a college or securing any benefit whatsoever.
9. Collection of funds for any program, picnic, excursion, project or activity without prior written permission of the appropriate authority.
10. Use of title of the college or title which includes the name of college for sending any letter or communication to the press or for distributing any documents or literature or publication other than academic work, without prior written permission of the appropriate authority.
11. Use of the name or address of the college or its Officers or Other authorities for making any representation on behalf of any student or a group of student to any public authority in India or elsewhere or to any person (including the press) other than a person responsible for the management of the affairs of the college.
12. A act which disrupts the smooth running of the college or environment conducive to the pursuit of knowledge or harmonious relationship between different groups of students.
13. An act which trends to lower in the public estimate the image of the college or their officers.
14. An act of unruly and disorderly behavior at any competitions, sports, cultural activities or other social or educational programs organized by the college.
15. An act involving moral turpitude.
16. Breach of ordinances and rules relating to attendance at lecture tutorials, tests terminal or preliminary examinations and progress to the satisfaction of the principal.
17. Being found in possession of goods or any material deemed objectional by the principal of college (In such cases, the principal may take or direct to take of such goods possession material pending enquiry, if necessary.)
18. Any act of insubordination or rude behavior or use of inappropriate language towards the principal or any Professor of the college or non-teaching staff.
19. Generally, any other act of indiscipline which, in the opinion of the principal of college is unbecoming of a student.

Procedure for imposing punitive action:

1. Any student of the college who has committed one or more of the acts of indiscipline mentioned above shall be subject to the disciplinary jurisdiction of the Principal, who may refer the matter to any professor or a committee of enquiry appointed for the purpose.
2. Every Student who has been alleged to have committed an act or acts of indiscipline shall be given an opportunity to be heard before any disciplinary action is taken against him/her.
