Legal studies are the one's which makes our society understand about the laws prevailing in the country. Legal studies offer following capabilities and expertise in the law sector such as -

Show expertise of the structure of the legal systems, and the jobs of law-making institutions which includes parliaments and higher courts, and examine the ones roles throughout common law, civil law and hybrid systems;

Display introductory information of the position of the legal profession;

Broaden and display introductory knowledge of the doctrine of precedent and the concepts of statutory interpretation, and then observe that expertise to case law and rules within the context of legal issues to demonstrate introductory level legal evaluation skills;

Broaden and demonstrate introductory level legal research abilities to find applicable primary and secondary legal sources;

Engage with the studying management system to increase and reveal legal study competencies and time management capabilities.



## Faculty

## B.A. LL.B.

The Bachelor of Arts - Bachelor of Legislative Law (BA LLB) course is an integrated law degree that the law aspirants can pursue right after qualifying for their Class 12th examinations. The law degree is an integration of Arts and Law subjects and is of a five-year duration. Therefore, as part of the BA LLB course, the candidates study subjects including Economics, History, Political Science, Sociology along with law subjects like Civil Law, Criminal Law, Labor Law, Tax Law, Administrative Law, Corporate Law, Patent Law, etc. The course-curriculum of BA LLB degree is such that law, as well as, the arts subjects, are included in each semester. Moreover, candidates are taught about law case studies, moot courts, law internships, seminars, and interactions with retired judges from High courts and the Supreme Court of India.

### **DURATION : 5 YEARS ELIGIBILITY : 10+2**

Candidates seeking admission to BA LLB course need to meet the eligibility criteria as mentioned by the law schools and universities in India including, academic qualification, minimum qualifying marks and age limit. If they have completed their 10+2 from a recognized board. Apart from this, most popular law colleges also fix a minimum marks requirement in order to be eligible to apply for the BA LLB course offered by them. By means of this criteria, candidates belonging to General/ OBC/ Specially abled person categories need to secure at least 45% marks at their 10+2 level in order to pursue a BA LLB course and the percentage fixed for General – 50%, SC/ST – 45%

The BCI (Bar Council of India) states no minimum or maximum age limit criteria is required for admissions to BA LLB course or five-year integrated law courses.

## Scope of B.A. LL.B.

BA LLB degree opens up a wide range of opportunities for the students. Most of the students who pursue this course wish to become a judge or an advocate. To become a judge or an advocate, student needs to clear the exam named AIBE (ALL INDIA BAR EXAMINATION). After clearing this exam, student will be granted with "CERTIFICATE OF PRACTICE". Now, the student can practice as an advocate in any part of India or can further give examination to become a judge.

This program is designed to provide students with a comprehensive understanding of the legal system, as well as critical thinking, analytical, and research skills that are essential for success in the legal profession. Students who have completed their BA LLB degree can prepare for entrance exams for the Indian Civil Service, State Legal Services, and Public Service Commission, among other career paths. Our institution is committed to providing our students with the resources and guidance necessary to help them succeed in their chosen career paths. We believe that our graduates will be well-equipped to make a meaningful contribution to society, both professionally and personally.

Students after graduation can prepare for the Indian Civil Service, State Legal Services and Public Service Commission Entrance exams.



## LL.B.

Bachelor of Law or LLB is an undergraduate degree program in law which allows students to become lawyer or to get into the depth of the law discipline. Libra College of Law is offering three-year Bachelor of Law or LLB program, divided into six semesters.

LLB stands for Legum Baccalaureus taken from Latin word which means "Bachelor of Laws". LLB is one of the foundation degrees to enter into practice of law. Through LLB, students are taught legal subjects such as constitutional, family, company laws and other constitutional rights. In this three-year undergraduate law degree program the entire curriculum revolves around legal subjects. After completion of LLB, students could choose to be a part of law firms, corporate firms, or banks as legal advisor, advocate, legal analyst or legal researcher and also go for the further higher education.

The objective of Bachelor of Laws is to make students understand the whole law education in India.

### **DURATION : 3 YEAR** **ELIGIBILITY : GRADUATION**

(The students need to be graduate or post graduate in any stream from any recognized university with at least 45% marks for General 50% and 45% for SC/ST candidates.)

## SCOPE OF LL.B.

There are numerous job profiles for LLB candidates. Some of the job profiles or mentioned below-

- **Civil Judge:** The foremost job one can attain is that a judge LL.B. prepares students and helps them in understanding the concept of "Justice" which in the long run motivates them to prepare for one of the toughest exams of India.
- **Prosecution Officer:** In criminal law it is the foremost duty of the state to prevent crimes and if any crime taken place the state has to prosecute the accused. Thus, by doing las one can prepare for the exam of persecution officer.
- **Corporate Firm:** After completing law one can join legal law firms and contribute greatly to the Indian economy. Moreover, great packages are given to beginners depending on their knowledge and skills.
- **Advocates:** After completing of LL.B. every law student has to get his/her self-registration under the State Bar Council. Then after clearing the AIB Exam they are entitled to practice law and they are called Advocates as per the Advocates Act, 1961.



# LL.M.

LLM also termed as Master of law is a one year postgraduate program within the subject of law. LLM is generally pursued after completion of LLB degree to become an expert in any LLM specializations together with international law, corporate law, business law, criminal law. LLM or Master of Laws is a globally recognized postgraduate degree, undertaken by students from unique academic backgrounds, however students with LLB heritage are given a choice. LLM degree is however best for candidates who are looking to develop their legal know-how in a specific component of law.

**DURATION : 1 YEAR**

**ELIGIBILITY : GRADUATION**

- Minimum qualification required is LLB (5 year integrated/ 3-year degree) from any recognized university.
- Minimum percentage required is 50% for GEN/OBC and 45% for SC/ST.

## Scope Of LL.M.

LLM candidates have vast job opportunities in their profession. They also can prepare for competitive exams like PCS-J. Some of the job profiles for LLM candidates are -

- **Academician:** After completion of LL.M. students have to qualify the UGC-NET exam before they can be appointed as Assistant Professor of Law in colleges and universities.
- **Ph.D. (LAW):** If a student is important in academics and higher studies then he/she can pursue Ph.D.in Law after LL.M.
- **Researcher:** After LL.M. the students can join various Government Organizations, NGO's, Law Firms, and other independent agencies as Legal Researchers which in a way enhances their skills and further contributes to the aforementioned bodies.





## MOOT COURT

At LIBRA College of Law, we have developed a "Moot Court" that provides our students with the opportunity to analyse legal topics and conduct in-depth research. Through this, our students learn to work in teams and collaborate with their peers to develop their advocacy skills. Participating in the Moot Court is an excellent way for our students to improve their confidence and speaking skills, as they are given the chance to demonstrate their abilities in a simulated legal setting. This is a valuable part of our curriculum, as it allows our students to apply the theoretical knowledge they acquire in the classroom to practical, real-world scenarios.

Mooting is a simulated court providing where student teams are presented with a legal problem that they are required to argue before "judge or panel of judges".





#### TERMS & CONDITIONS FOR SCHOLARSHIP, ITS DIFFERENT PHASES AND EARLY ADMISSION

1) The scholarship shall be awarded based on aggregate marks of Class XII or bachelor's result. In case of CGPA, it shall be converted according to CBSE/ICSE/National Board/UGC/University norms. If the conversion criteria are not mentioned in the mark sheet, then the following criteria shall be applicable:

2) Scholarships in the bracket of 95% or more marks may be awarded to applicants who have obtained 10 CGPA.

3) Scholarships in the bracket of 90% to 95% marks may be awarded to applicants who have obtained 9.5 CGPA to 9.99 CGPA.

4) If a student gets a scholarship from a government/NGO/other agency, the Scholarship amount would be restricted to the difference of the sanctioned amount by Govt./NGO/other agency and Scholarship at Libra. This decision is at the behest of the Libra College of Law Scholarship Committee.

5) Scholarships are based on early admission and are further subject to availability of seats, course applied, documents authentication as per requirement of the institution.



7) Scholarship in the bracket of 80% to 90% marks may be awarded to applicant who has obtained 8.5 CGPA to 9.49 CGPA

8) Scholarship in the bracket of 70% to 80% marks may be awarded to applicant who has obtained 7.5 CGPA to 8.49 CGPA

Scholarship offered may be on different basis such as scholarship based on Uttarakhand Domicile, Scholarship based on percentage, Scholarship based on Sports, Cultural, R&D, Co-curricular, Social Service etc. Scholarship based on AIBFEE or Qualifying examinations such as CLAT. But it can be availed only under one category. Also, Scholarships shall be applied at the time of application or till the last date of particular path or subject to seat availability. It shall not be allowed to change/apply at a later stage. Curricular, Social Service, etc. will only be awarded in case of competition meeting the guidelines approved by the said organizations as mentioned on scholarship page. Students applying for admission through Scholarships will be required to upload documents/proof/certificates in the application portal after receiving login credentials for verification and authentication. Certificates validity from 31st March 2024 till the date of application shall be accepted only.
