INTRODUCTION

Narayan Medical College & Hospital, Jamuhar, Sasaram was established by Deo Mangal Memorial Trust with the sole aim of imparting the clinical facilities to the poor, needy downtrodden, helpless and deprived people of the society by the qualified doctors of different specialties. Besides this, it has also aim of imparting the good quality teaching & training to the young students admitted in this Institution to become a responsible, sensible & kindhearted doctors, social workers, researchers & future teachers of medical college & to develop human values.

The Institute is a residential campus with sufficient accommodation for the faculty members, staff and the students inside the campus. There are 2 hostels for undergraduate students (1 for boys and 1 for girls) with a capacity to accommodate 1250 students and 2 hostel for Intern and PG student. Hospital has 1150 teaching beds. Beside this there is fully functional round the clock casualty and ICUs. All the 12 OTs are modular. Dialysis, Plastic Surgery, Neurosurgery, Urology and Cardiology and oncology units are well functional. All the five lecture theaters are air conditioned and fully equipped with audiovisual aids. There is sprawling playground with all playing material. Gymnasium is available. Library is fully air conditioned with sufficient number of books and journals. E-library facility and computer facilities are available for both teachers and students. Clinical material in both OPD and IPD are sufficient for standard clinical teaching.

The Prime concern of the Institute is to develop educational principles and practices already adopted here, are those which are the best suited to the needs of the country and to meet the problems of community health. The institute has an objective to provide affordable medical facilities to the needy and poor masses of in and around Rohtas including nearby districts of Bihar and Jharkhand. Regularity of session is primary object of the institution. The undergraduate curriculum is consistently reviewed by College Council and the required changes in the curriculum are brought which is the most suitable for the Indian needs and conditions fully abiding by MCI norms. Curriculum are designed on competency, Skill, Communication & ethical based. The aim is to produce ideal Indian Medical Graduate per recommendation of National Medical Commission.

NUMBER OF SEATS :

The Institute is recognized for 250 Seats for the awards of Bachelor of Medicine and Bachelor of Surgery (M.B.B.S.) degree by National Medical Commission, New Delhi Since 2023 and PG (MD/MS) in all Subjects (except PSM, FMT, TB Chest & Psychiatry)

HOSTEL ACCOMMODATION :

1. Separate hostel accommodation is available for Boys and girls students.
2. Application for accommodation in the hostels should be submitted in the prescribed form along with the assurance by the parents or guardian for the good conduct and behavior of the candidate during his/her stay in the hostel. Admission to hostel will be made by the warden on approval by the Managing Director/Principal.
3. When the conduct and character of a student is not satisfactory or is of suspicious nature, the director/principal reserves the right, without assigning any reason either to make him/her vacate the hostel or to expel him/her from the institute & retain the entire fee submitted.
4. Hostel rules are notified. The inmates of hostel have to abide all the hostel rules as per college code of conduct & Hostel Manual

CRITERIA FOR BENCHMARK DISABILITIES (OH/PH):

The candidate must possess a valid document certifying his/her physical disability. The disability certificate should be produced by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions.

5% seats of the annual sanctioned intake capacity shall be filled up by candidates with benchmark disabilities in accordance with the provisions of the Rights of Persons with Disabilities Act, 2016, based on the merit list of 'National Eligibility-Cum-Entrance Test' **in terms of notification published on 23.01.2018 in Gazette of India**

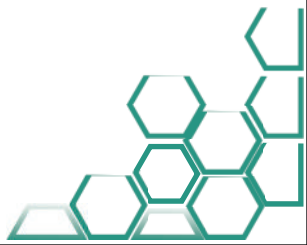

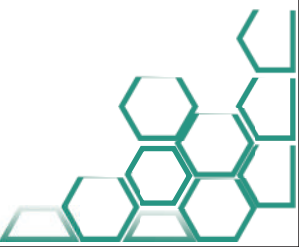
ELIGIBILITY:

No candidate shall be allowed to be admitted to the Medical Curriculum proper of first Bachelor of Medicine and Bachelor of Surgery course until he /she has qualified the National Eligibility Entrance Test, and he/she shall not be allowed to appear for the National Eligibility-Cum- Entrance Test until:

1. He/she shall complete the age of 17 years on or before 31st December of the year of admission to the MBBS.
 - a. He/She has obtained a minimum of marks in National Eligibility-Cum- Entrance Test as prescribed in Clause 5 of Chapter II.

PROCEDURE TO APPLY:

All qualified candidates of NEET-2024 must register himself/herself in BCECE Board and undergo counseling. College will be allotted as per their merit cum choice basis. They have to report to the allotted college as per time schedule. Delay in reporting will forfeit their claim for admission.

MEDICAL EXAMINATION :

The selected candidates will have to undergo medical examination by a Medical Board set up by the Institute. If a candidate is found medically unfit by the Board as per regulation, then his/her candidature for admission will be rejected. The decision of the Board shall be final.

IMPORTANT POINTS TO NOTE :

1. Admission of candidates is strictly provisional.
2. If ineligibility of a candidate is detected at any stage, his/her admission will be cancelled without any notice.
3. In case any candidate is found to have furnished false information or certificate etc. or is found to have withheld or concealed any material information his/her admission will be cancelled even during MBBS Course.
4. If any candidate is found to be indulged in unlawful activity or breaks the rules and regulation of institution/hostel, strict action will be taken against him/her including rustication/dismissal from the college and hostel.

ATTENDANCE:

75% attendance in each subject in lecture and 80% in seminars, group discussions, tutorials, demonstrations, practical, Hospital postings and bed side clinics, etc (separately) compulsory for sent-up for the University Examination, No leave will be granted except list of Holiday issued by GNSU.

COMPULSORY ROTATORY INTERNSHIP TRAINING:

After passing the Final M.B.B.S. examination, all the candidates will be required to undergo compulsory rotatory internship for a period of one calendar year (12 months) in the hospital and rural health centers recognized by the institute. During the internship period, the interns are allowed a total of 15 days leave in full term of one year. The degree of M.B.B.S. shall be awarded to them only after satisfactory completion of one year compulsory rotatory internship.

COURT JURISDICTION :

SUPREME COURT RULES REGARDING ANTI RAGGING :

As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside the campus and the College authorities are determined not to allow any form of ragging. Whosoever directly or indirectly commits, participates in, abets or instigates ragging within or outside college shall have an FIR lodged against him/her and he/she will be suspended or rusticated from the institution and shall also be liable to be fined which may extend to Rs. 1,00,000/-. In case the applicant for admission is found to have indulged in ragging in the past or if it is

noticed later that he/she has indulged in ragging, admission can be refused or he/she shall be expelled from the institution. The punishment may also include suspension from attending the classes, withholding/ withdrawing fellowship/ scholarship and other financial benefits or withholding the result.

The candidates as well as their parents, at the time of admission to this Institute, will be required to furnish an undertaking in the form of an affidavit that the candidates will not be indulged in any form of ragging. No incidence of ragging was reported in last many years in this institute.

“RAGGING” INCLUDES THE FOLLOWING:

ANY CONDUCT WHETHER BY WORDS SPOKEN OR WRITTEN OR BY AN ACT WHICH HAS THE EFFECT OF HARASSING, TEASING, TREATING OR HANDLING WITH RUDENESS ANY OTHER STUDENT, INDULGING IN ROWDY OR UNDISCIPLINED ACTIVITIES WHICH CAUSES OR IS LIKELY TO CAUSE ANNOYANCE, HARDSHIP OR PSYCHOLOGICAL HARM OR TO RAISE FEAR OR APPREHENSION THEREOF IN A FRESHER OR A JUNIOR STUDENT OR ASKING THE STUDENTS TO DO ANY ACT OR PERFORM SOMETHING WHICH SUCH STUDENT WILL NOT IN THE ORDINARY COURSE AND WHICH HAS THE EFFECT OF CAUSING OR GENERATING A SENSE OF SHAME OR EMBARRASSMENT SO AS TO ADVERSELY AFFECT THE PHYSIQUE OR PSYCHE OF A FRESHER OR A JUNIOR STUDENT. 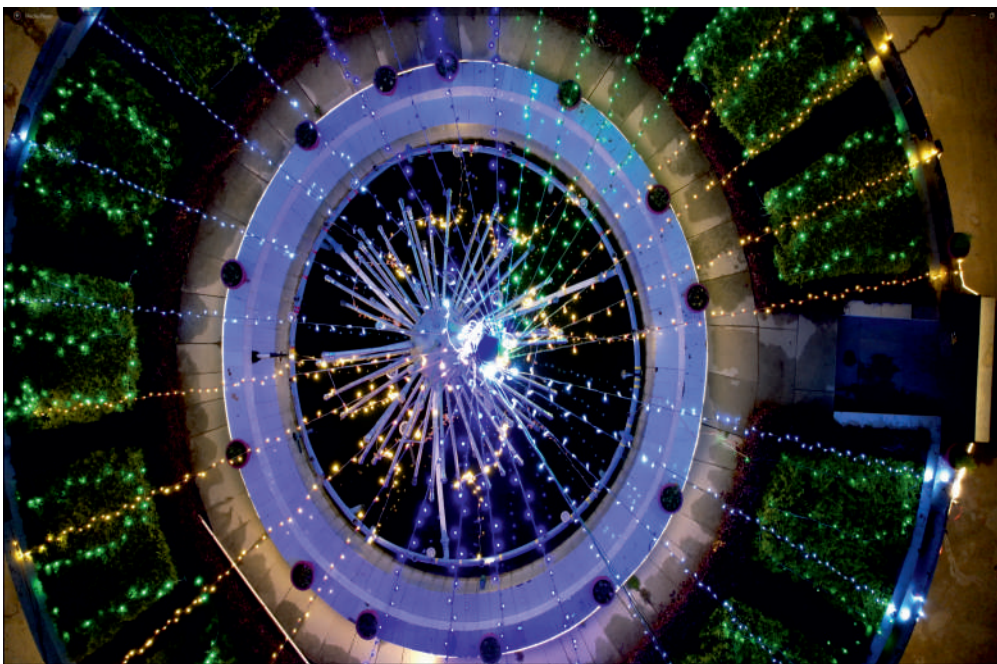
