# A TRIBUTE TO

## Architect of Indian Constitution

**Dr. B.R. Ambedkar**

**D**r. **Bhimrao Ramji Ambedkar** was born on 14 April 1891 in a 'Dalit' family, popularly known as Baba Saheb. He was an Indian jurist, economist, politician and social reformer who inspired the Dalit Buddhist Movement and campaigned against social discrimination against Untouchables (Dalits). Dr. Ambedkar was a prolific student, earning doctorates in economics from both Columbia University and the London School of Economics, and gained a reputation as a scholar for his research in law, economics and political science. After India's independence on 15 August 1947, the new Congress-led government invited Dr. Ambedkar to serve as the nation's first Law Minister and on 29 August, he was appointed as Chairman of the Constitution Drafting Committee to write India's new Constitution.

Indian Constitution drafted by Dr. Ambedkar is described as 'first and foremost a social document' which was presented before the nation in 1948 which structured the legal system of Independent India. It is considered as longest written Constitution of any sovereign country in the world, containing 448 articles in 26 parts, 12 schedules and 104 amendments. In October 1948, Dr. Ambedkar submitted the Hindu Code Bill to the Constituent Assembly in an attempt to codify the Hindu Law. The Constitution was adopted on 26 November 1949 by the Constituent Assembly and came into effect on 26th January 1950. He was Independent India's first law minister, the principal architect of the Constitution of India and a founding father of the Republic of India.

Dr. B R Ambedkar initiatives have influenced various spheres of life and transformed the way India today looks at socio-economic policies, education and affirmative action through socio-economic and legal incentives. He left this world on 6th December 1956 after prolonged illness at his home in Delhi. He was posthumously conferred with India's highest civilian award "**Bharat Ratna**" in the year 1990.

## ELIGIBILITY & ADMISSION PROCEDURE

### 5 Years B.A. LL.B. Integrated Course

- A candidate who has passed an examination in 10 + 2 course of a school recognized by the educational authority of Central or State Government with 45% marks in aggregate with five subjects **including the subject of English** shall be eligible to seek admission in the first semester of B.A.LL.B. 5 - Year Integrated Course.

Explanation : The candidates who have obtained 10 + 2 through Open University System directly without having any basic qualification i.e., Matric/Secondary/10 + 2 are not eligible for admission in the B.A.LL.B. 5-Year Integrated Course.

- **The candidates who have done graduation or Postgraduation shall not be eligible for B.A.LL.B. 5 Year Course.**
- The minimum eligibility condition in the case of SC/ST/DAP/EBP Candidates shall be 42.75% marks in the qualifying Examination with **English as one of the subjects**. (There shall be no rounding of percentage of marks of the qualifying Examination i.e. 40% and 50% means exact percentage. Thus, 42.5% and above does not mean 43% or 44.5% and above does not mean 45%).
- The candidates who have appeared for the final year of 10 + 2 Examination and whose results have not been declared may also apply at their own risk and responsibility subject to the fulfillment of the above-mentioned eligibility conditions on the date of admission.

### 3 Years LL.B. Course

- Bachelor's Degree or Master's Degree Examination of the Ch. Bansi Lal University or any Examination recognised as equivalent, with English as one of the subjects in the qualifying examination and with atleast 45% marks in the aggregate (42.75% for SC/ST/DAP/EBP candidates) in either of these Degree (One-Year Degree/Diploma Courses like, D.P.Ed., M.Ed., B.Ed., B.Lib. Sc., etc. shall not be considered as equivalent to Bachelor's Degree). Eligibility condition for differently abled candidates shall be 42.75% marks in qualifying examination with **English as one of the subjects**.

### 2 Years LL.M. Course Evening (2nd Shift)

- A person, who has passed Bachelor Degree in Law recognized by State Universities of Haryana as equivalent thereto with at least 50% marks in aggregate or equivalent grade, shall be eligible for admission to the First Semester of the LL.M. Courses.

- Note:**
1. The relaxation in qualifying marks/percentage for SC/ST/PH categories shall be as per state government directions received from time to time.
  2. Candidate having compartment in the qualifying examination shall not be allowed be admission to the course even provisionally.
  3. The medium of Instructions shall be in English only however students are at liberty to answer in Examinations either in English or Hindi.

**Application Fee : Rs. 500/-**

## ADMISSION RULES

- Each candidate will have to apply for admission on the prescribed application form attached or given along with the prospectus.
- Each candidate is required to bring original certificates and detailed marks sheet of matriculation, 10+2, B.A. / B.Com. / B.Sc./ LL.B. or any other equivalent examinations along with three attested photocopies of each and four latest passport size coloured photographs at the time of seeking admission.
- Character certificate issued by the institution last attended is required to be submitted by candidates at the time of seeking admissions.
- Migration certificate in original (applicable to the candidate coming from other Universities / Boards other than those of Haryana School Education Board) is required at the time of seeking admissions.
- A student leaving the college without paying the college dues shall not be allowed re-admission unless he/she pays the earlier dues.
- Principal has an absolute power to deny admission to any student without assigning any reason and his/her decision in this regard shall be final.

**NOTE:** The Principal of the college and the Admission Committee have an absolute right to amend / modify any of the college rules as contained in the prospectus during the current session.

## OTHER RULES REGARDING ADMISSION

1. All the rules , regulations, instructions and guidelines etc. as contained in the prospectus are liable to be changed in conformity with the orders / directions / instructions etc. received from the University from time to time and such amended rules regulations / instructions / guidelines are binding on the student to follow. The college will make every possible effort to inform the students of such amendments / changes in the rules / regulations / instructions etc. but does not own responsibility to this effect.

2. It will be the personal responsibility of the student concerned to ensure before effecting admission as to whether he/she is eligible or not for any courses of studies or subjects and the college will not own any responsibility regarding this matter.
3. The admission of such student in that course / subject will be cancelled as soon as the facts come to the knowledge of the college and the fee / funds paid by the candidate shall not be refunded

## DISCIPLINE & ANTI - RAGGING WARNING

It is expected that all the boys and girls move themselves within the College campus with due dignity and decorum. It is expected that all the students must accord highest respect to the members of faculty and staff and their family members. Any damage to the Institute's property will have to be compensated by the student concerned.

As per the Hon'ble Supreme Courts' verdict, directive of Govt. of Haryana, affiliating University and UGC guidelines, any type of physical or psychological ragging is strictly prohibited within the campus or outside and if any student found contravening these regulations, will be expelled from the College. All students seeking admission to the College are required to submit a declaration, duly countersigned by the respective guardians that ragging being a social crime, he/she would never encourage/indulge in ragging and in case found guilty, he/she shall be liable to be expelled from the College apart from the possibility of a hefty fine, as per Hon'ble Supreme Court's Order. The student would not be eligible for admission in any other Institute too.

Smoking, consumption of alcohol, use of drugs, chewing pan and zarda are strictly prohibited within the campus.

**Offenders will be severely punished as per College norms and practices.**





## IMPORTANT INSTRUCTIONS

- It is mandatory for every student to attend at least 75% of the lectures delivered in the class otherwise the student will have to pay fine for short attendance or he/she will not be allowed to appear in the final examination.
- Students should visit and observe the college Notice Board daily to keep themselves abreast of the latest instructions and informations. Ignorance in this regard shall be no excuse.
- If any wrong information is furnished or facts are concealed knowingly or un-knowingly by any student, his / her admission shall be liable to cancel without giving any prior notice.
- Principal as well as the Board of Governors of the College reserves the right to amend, to modify or add any rule and regulation as warranted under the precipitating circumstances.
- Plucking of flowers or harming the greenery and tiny plants on the college campus is strictly prohibited. The concerned student will be fined for that.
- Bearing Identity Card in college campus is mandatory.

## COLLEGE RULES & REGULATIONS (ATTENDANCE AND EXAMINATION)

1. Leave application on account of illness of a candidate should be accompanied with a medical certificate which should reach to the class in charge on the very 1st day of leave application.
2. 75% attendance in each subject is compulsory failing which the candidate concerned shall not be allowed to appear in the semester examinations.

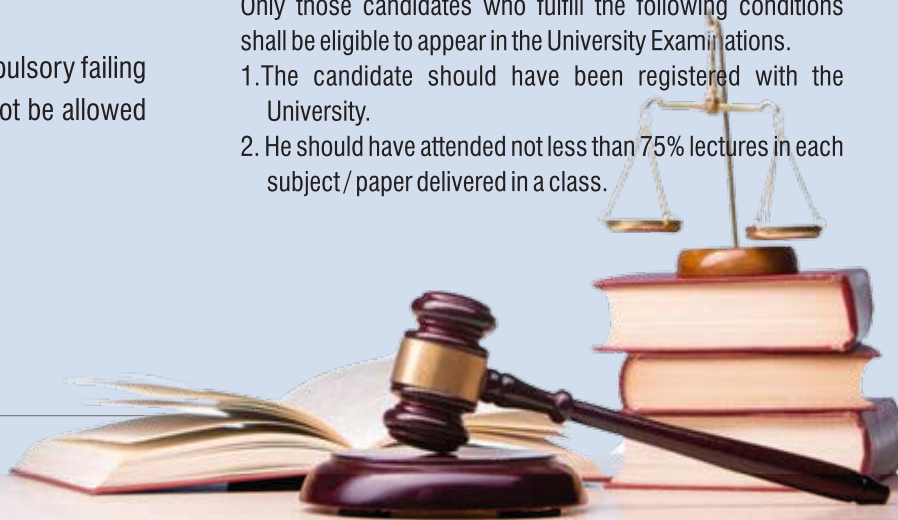
## RULES & REGULATIONS

It is moral and legal duty of every student seeking admission that he/she must honestly follow the college rules and regulations and maintain their dignity. If any student is found involved directly or indirectly in any subversive/mean conduct/behavior or violation of college rules or in any other activity which in the opinion of the principal is an act of indiscipline, an information to this effect will be immediately sent to his/her parents/guardians and also shall be liable for monetary punishment by the principal or he/she can be suspended from attending the classes or expelled/rusticated from the college. If any student is found guilty of vitiating the academic atmosphere of the college, the college principal on the recommendation of high powered disciplinary committee will have an absolute right to expel him/her from the college or to get police action initiated against him/her.
4. The College Principal reserves all the rights. It is the moral obligation of every student to abide by his/her orders. Every punitive rights are vested in the college Principal to inflict/award punishment to a student who does not follow any rules or found involved in any in disciplinary activities.
