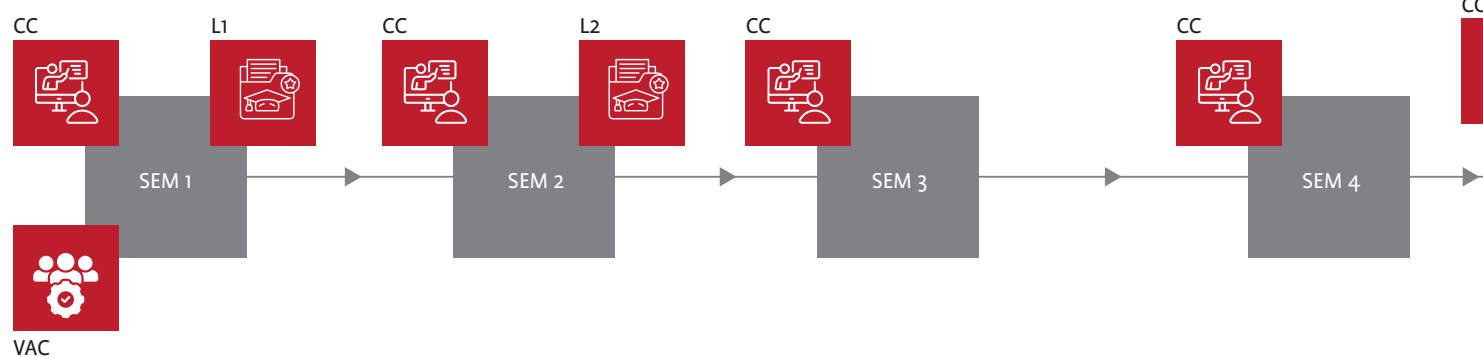

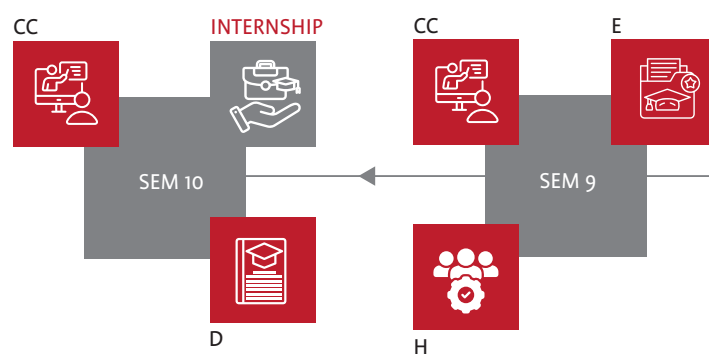




Learning Model



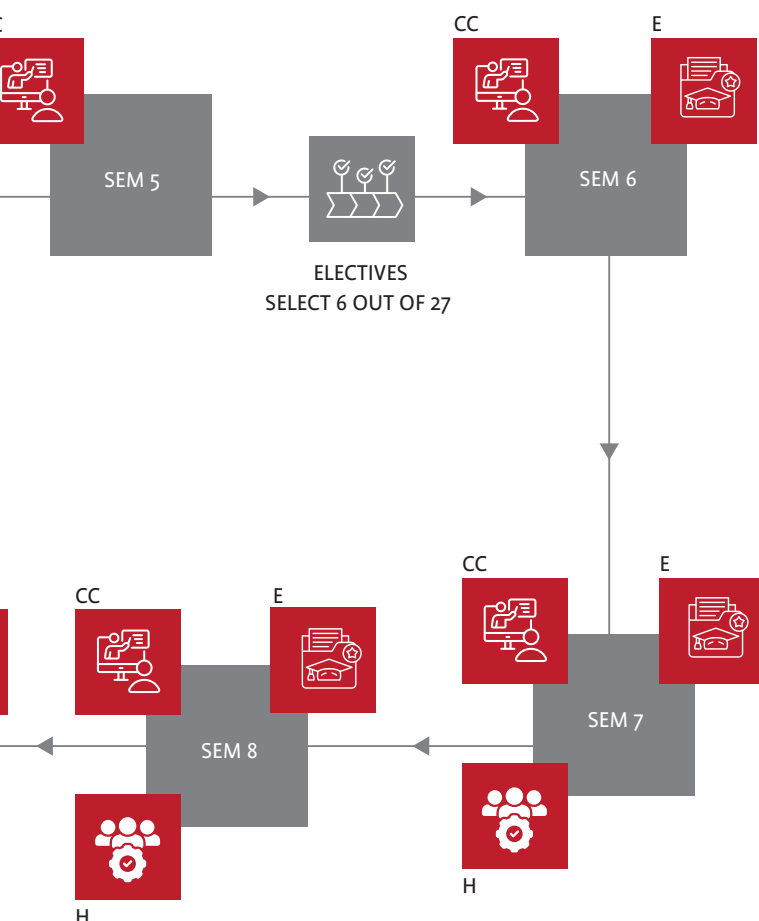

Programme Structure

The BA LLB and BBA LLB programmes at Unitedworld School of Law blend law courses with non-law subjects from Social Sciences and Management etc as recommended by the Bar Council of India. Eligibility Criteria

- Candidates should be Class XII students who have appeared for or are awaiting their final results.
- All applicants must meet the requirements set forth by Karnavati University and/or the Bar Council of India.

Selection Process

- The university accepts scores from the CLAT (Common Law Admission Test).
- Alternatively, candidates can opt to appear for the Karnavati University Admission Test (KUAT).
- The selection process includes a Personal Interview.
